

## **Based Defensive Systems Range Membership Agreement**

This Membership Agreement ("Agreement") is between Based Defensive Systems LLC ("Owner") and the undersigned "Member" and includes the following terms:

### **Membership Term**

1. Annual Memberships last 1 calendar year from the signing date for annual memberships.
2. Monthly memberships are billed via credit/debit card at the beginning of each month.

### **Membership Fees and Tiers**

3. Fees are due on the 1st of each month for monthly members. Annual membership fees are due at the beginning of membership and renew 1 year from the start of membership.
4. Memberships are non-refundable and non-transferable.
5. Individual Membership is \$40/month paid via credit or debit card, or \$400 per year if paid annually. This membership tier includes only the sole member.
6. Household Membership is \$50/month paid via credit or debit card, or \$500 per year if paid annually. This membership tier includes yourself, spouse/significant other, and dependents living with you. Standard guest fees apply for anyone outside of the household.
7. Memberships billed monthly are on a 6-month rolling commitment, beginning the month joined.

### **Range Access**

8. Members may use the range at any time, except for when classes, shooting events, or private functions are being held.
9. Low-light/no-light training is allowed with owner approval.
10. Members may rent the range for exclusive use for additional fees provided no classes or events are scheduled. For any questions regarding scheduling or availability, call Based Defensive Systems at 330-984-1787.
11. The Owner may adjust operating hours for maintenance or construction.

### **Code of Conduct**

12. Members must follow all firearm safety rules.
13. Members must always adhere to the Four Firearm Safety Rules:
  - Treat every firearm as if it is loaded.
  - Never point a gun at anything you do not intend to destroy.
  - Keep your finger off the trigger until ready to shoot.
  - Be sure of your target and what's beyond it.
14. Unsafe behavior may result in suspension or termination without refund.

### **Liability Waiver**

15. Members acknowledge the risks of firearms use and must sign the range waiver.
16. The Member releases the Owner from liability for any claims, damages, or injuries.

### **Vehicles**

17. Members are responsible for the safe operation of their vehicles. Based Defensive Systems is not responsible for any damage to vehicles.
18. Stuck vehicles are the responsibility of the member.

### **Firearms & Ammunition**

19. All firearms and ammunition must comply with local, state, and federal laws.
20. The owner or staff may inspect firearms/ammunition for safety.
21. Violations may result in removal, suspension, or termination.

### **Guest Policy**

22. Guests are allowed for a \$10 fee per visit.
23. All guests must follow range rules and sign a liability waiver.
24. Members are responsible for their guests' conduct.

### **Membership Termination and Cancellation**

25. The Owner may terminate membership for violations or at their discretion.

26. No refunds will be provided if membership is terminated.

27. If a member cancels before completing their current 6-month commitment, a \$50 early cancellation fee applies. Cancellation requests must be in writing via text or email. Members who cancel and later return must pay a \$25 rejoin fee.

### **Identification & Verification**

28. All individuals listed under a membership- including household members 16 years of age or older- must submit a copy of a **valid driver's license or government-issued ID** for verification.

### **Vehicle Information**

29. Members must provide the make, model, color, and license plate number of any vehicle(s) they may drive onto the property. Updates must be reported as changes occur.

### **Range Use & Target Rules**

30. The 25-yard pistol range (left side) steel targets are for handgun calibers only — rifle and shotgun ammunition is prohibited. The 50-yard range (right side) steel targets are rifle-rated and may be used with appropriate calibers at safe distances. Members are responsible for ensuring proper range and target use.

### **Waiver, Payment & Compliance**

31. Shooting or range use without payment and a signed waiver is strictly prohibited. Violation constitutes trespassing and is grounds for immediate termination of membership and permanent ban from the property.

### **Membership Fraud & Enforcement**

32. Any attempt to falsify or stack memberships (such as listing non-resident or non-dependent individuals under a household plan) will result in immediate termination. Unpaid fees and damages will be invoiced and sent to collections. Membership privileges will be permanently revoked.

### **Payment Authorization**

33. Monthly members authorize monthly credit card charges for membership fees. Changes to card details must be reported promptly. Failure to pay may result in suspension and permanent loss of membership. Members paying annually have the option to submit a check with their Range Membership Agreement, Range Waiver, and ID.
