

Based Defensive Systems Firearm Rental Agreement & Liability Waiver

This Agreement ("Agreement") is entered into between Based Defensive Systems LLC ("Owner") and the undersigned individual ("Renter"). By signing this document, Renter acknowledges and agrees to all terms and conditions below.

Eligibility and Identification

1. Renter must be 21 years of age or older to rent handguns or rifles.
2. Renter must present a valid government-issued photo ID prior to rental.
3. Renter must not be prohibited under federal, state, or local law from possessing firearms or ammunition.
4. Firearms may not leave the property under any circumstances.

Range Use and Supervision

1. All rentals must occur on-site under supervision of the Owner or authorized staff.
2. Owner reserves the right to refuse or terminate any rental for unsafe behavior or policy violations.
3. Range time, supervision, and use of targets are included as specified per rental session.

Ammunition Requirement

1. All ammunition must be purchased from Based Defensive Systems on the day of rental.
2. Outside ammunition is strictly prohibited.
3. Failure to comply will result in immediate termination of the rental and forfeiture of all fees.
4. Renter is responsible for the full cost of all ammunition used.

Payment and Prepayment

1. Prepayment is required for all rentals, ammunition, and range fees before firearms are issued.
2. All transactions are final; no refunds will be issued once firing begins.
3. Rentals may be charged per firearm, per hour, or per session as determined by the Owner.
4. Damage, loss, or cleaning fees are payable immediately upon determination by staff.

Firearm Care and Damage Responsibility

1. Renter assumes full responsibility for any damage, misuse, or negligent handling of the firearm during the rental period.
2. Damage includes cracked optics, broken parts, misuse of ammunition, or unsafe operation.
3. Renter shall not disassemble, modify, or attempt repairs on any rental firearm.
4. The Owner will assess repair or replacement costs at their discretion; Renter agrees to pay immediately.

Safety and Conduct

1. Renter must follow all firearm safety rules:
 - Treat every firearm as if it is loaded.
 - Never point a firearm at anything you do not intend to destroy.
 - Keep your finger off the trigger until ready to shoot.
 - Be sure of your target and what is beyond it.
2. Eye and ear protection are mandatory.
3. No alcohol, drugs, or intoxicants before or during range use.
4. Unsafe or reckless behavior will result in immediate removal and permanent loss of rental privileges.

Liability Waiver

1. Renter understands that shooting activities involve inherent risks, including serious injury or death.
2. Renter voluntarily assumes all risks associated with firearm use and range participation.
3. Renter releases and holds harmless Based Defensive Systems LLC, its owners, agents, and employees from any liability, claims, damages, or expenses arising from participation, equipment use, or negligence.
4. This release extends to all acts of negligence, whether active or passive, by the Owner or its staff.

General Policies

1. Range use and rentals are subject to all posted and published Based Defensive Systems policies and signage.
2. This Agreement is non-transferable and applies only to the undersigned Renter.
3. The Owner may change pricing, policies, or availability at any time.
4. Range activity may be recorded for safety and liability purposes.
